MICHIGAN

- Law Enforcement Information Network (LEIN)
 - Equivalent of DCI in NC
 - Went live in 1967
 - Access to NCIC and NLETS
- CJIS Policy Council formed in 1998
 - Michigan State Police
 - LEIN Policy Council
 - AFIS Policy Council
 - CJIS-Criminal Justice Information Systems
 - Michigan Sheriffs Association
 - Michigan Association of Chiefs of Police
 - Detroit Police Department Chief, etc.



INTEGRATION

CJIS POLICY COUNCIL'S VISION AND MISSION

“Enhance the safety of Michigan’s citizens by providing the ability to access and share complete, accurate, and timely information for public safety purposes.”

“Create and maintain an accessible and appropriately secured information system on individuals and events for criminal justice and public safety users that supports effective administration of the justice system, public and officer safety, and public policy decisions in a cost effective manner within the State of Michigan.”

INTEGRATION

CJIS POLICY COUNCIL'S GOALS

- Define an integrated system
- Define criminal justice information stakeholders
- Define operational requirements
- Develop a strategic plan for implementation of a system meeting the needs of all the stakeholders
- Secure sufficient funding to support implementation

(approved by the CJIS Policy Council October 19, 2000)


OBTAIN CONSENSUS ON A BUSINESS MODEL

- Participating Agencies own their own data
- Participating Agencies control their own data
- Maintain our own systems
- Accessible and secure
- Share across disparate networks
- Available in a mobile environment
- To get to the data, you must share your data

DATA SHARING SYSTEM: ISERVICES GATEWAY


- What is the ISERVICES Gateway?
 - “Google for Law Enforcement” or “One-Stop Shopping”
 - Distributed, federated query system searches in real time
 - Not a centralized data warehouse
- Primary Purpose
 - Facilitate the Sharing of Criminal Justice Information, Intelligence, and Photographs among Federal, State, and Local Law Enforcement Agencies with Disparate Computer Systems and Databases.
- US DHS ITEP Grant for Information Sharing in 2004


PROJECT IGNITE: DEVELOPMENT THROUGH EVOLUTION

- **Second Evolution** Upgrade and enhance crime analysis in all 13 counties of Region 6
- **Third Evolution** Provide a *shared, real time, web-based means of publishing* criminal intelligence crime analysis information throughout Region 6


PROJECT GOALS

- Provide ISERVICES Access to Region 6
- Provide Crime Analysis Software to Region 6
 - Additional capabilities designed for investigators
 - Allows search on “Associations” for other people based on address, phone number, victim, etc.
- Support the State Fusion Center in Region 6
- Each Evolution involves enhancements to the existing system


REGIONAL DATA SHARING IN MICHIGAN

- Support for multiple client tools
- Information is in real time
- Supports technology standards (GJXML, NIEM, etc)
- Includes auditing capabilities
